Responsibilities:

- Inspects car and locomotive components for compliance with AAR, FRA, and company standards
- Performs maintenance activity, both scheduled and on demand, including air brake tests
- Repairs, removes or replaces defective components such as wheels, safety appliances, truck and brake equipment, couplers, yokes, draft gears, air brake valves; welds broken parts or secures new parts
- Prepares numerous written reports and forms including bad order forms, car repair billing forms, and dimensional loading forms
- Performs re-railing or repair activities and emergency repairs anywhere on the system.
- Repairs, removes, or replaces components with the use of jacks, blocks, cutting and heating torch, and other hand tools
- O Restores track after derailments; manages the right of way and structures for trains
- O Corrects deviations in track surface, alignment, and gauge using appropriate tools
